Executive Summary

Tender T2024/11 Vacuum Excavation and Pump Out Services was undertaken to form an un-ranked panel of approved suppliers for the provision of Vacuum Excavation and Pump Out Services. These services can be utilised on a daily basis by various departments within Council on multiple sites within the Lismore Local Government Area and may be part of planned maintenance activities such as grit removal or as an emergency response in the event of plant breakdowns.

Ten submissions were received and assessed under this tender, with five suppliers deemed suitable for inclusion on the un-ranked panel of approved providers.

It is proposed that the approved panel of providers be accepted as outlined in this report for an initial one-year period with an option for two additional one-year periods. The recommended panel of suppliers are included in this report.

Background

The use of Vacuum Excavation and Pump out services has been a necessary requirement for Council's daily operations for numerous years. Vacuum excavation enables the safe exposure of inground services as part of preliminary, construction and maintenance activities. Pump out services are essential for the management of our treatment plants and pump stations in the event of planned or unplanned shutdowns and emergency breakdowns.

A panel of ranked suppliers for the Supply of Vacuum Excavation and Flow Control (pump out) Services (T2020/18) was established in July 2020, with the final extension period concluding in June 2023. This panel is currently operating on a month-by-month extension basis.

A financial analysis of T2020/18 was conducted, with results indicating approximately \$2.1 million dollars being the total amount expended across five (5) different contractors over the three-year duration of the panel contract.

Consultation was undertaken with key end users and responsible staff, including Manager Water & Wastewater, Co-ordinator Water Treatment & Trades and Co-ordinator Water & Wastewater, to ascertain if a ranked or unranked panel was preferred. The option to establish a new panel of unranked suppliers was preferred and is the best option to satisfy Councils requirements.

Feedback from key end users has been that the model of the previous panel (T2020/18) being ranked, was not successful and is not preferred, due to the availability and scheduling of contractors, and changes in conditions during the lifespan of the contract making the ranking system ineffectual.

Due to the varying nature and value of the work programs to be carried out, a public tender was conducted, and tenderers were invited to submit a tender submission on a Schedule of Rates basis for the supply of all labour, plant, fleet and equipment to complete the works and enable a direct comparison of related costs from provider to provider.

Tender Submissions

The Request for Tender was advertised via Council's eportal VendorPanel, Local Matters and Lismore City Council's website.

Tender submissions were received from ten suppliers by the close of tender at 1pm, 11th June 2024.

No late submissions were received.

Tender Evaluation

The tender evaluation panel comprising of Council's Manager Water & Wastewater (Chair), Coordinator Water Treatment & Trades, Team Leader Wastewater Maintenance and Procurement Officer undertook the assessment of tenders received.

The evaluation was conducted in accordance with the Local Government Tendering Guidelines, Regional Procurement Tendering Code of Conduct and Tendering Evaluation Principles and Processes. As a group the panel reviewed the submissions accepted and scored them against the criteria from the procurement plan and as advertised in the Request for Tender.

Confidentiality and probity were maintained throughout the process.

Potential non-conformities for all were noted in the evaluation matrix for the consideration of the panel.

Methodology

The following criteria and weightings were used to assess the submission received:

Due to the varying nature of the work, tenderers were invited to complete a schedule of rates. A comparison of the rates was undertaken through four typical hourly hire and after hour scenarios based on the rates tendered. The associated costs resulting from these comparisons are listed below:

It is noted that the only Lismore based supplier, Summerland Environmental provided the best overall price.

Capability, Experience and Availability

All tenderers demonstrated varying degrees of capability and experience in terms of size, capacity and the number of plant items available, to the necessary accreditations held by their operators.

Council has frequently engaged the services of Summerland Environmental and Mega Waste Industries Pty Ltd, with staff reporting suppliers provided a very good level of availability, capability and experience. Field Directional Drilling, Dynamic Hydro Excavation Pty Ltd and Total Drain Cleaning Services Pty Ltd T/as TDG Environmental, have also been utilised by staff to a lesser degree, whilst providing a good level of capability and experience.

All other tenderers documented in their submissions varying degrees of capacity, capability and experience within the industry providing services for various Queensland councils and private companies however council staff have not used the services of these tenderers previously.

WH&S, Environment and Quality Management System

Tenderers were required to outline their WH&S and Quality Management Systems in relation to the supply of Vacuum Excavation and Pump Out Services in order to be included on the approved panel of providers. All submissions were deemed conforming based on the information received.

Local Content

Summerland Environmental Service is located in the Lismore Local Government area with the majority of their employees residing within 50km of Lismore.

Field Directional Drilling and Mega Waste Industries Pty Ltd are located in the Ballina Local Government area and demonstrated varying numbers of employees residing or direct spend within the Lismore and Regional area.

All other tenderers are located in Southeast Queensland.

The tender assessment panel considered the local proximity of each tenderer along with the availability and capacity of the particular specialist skill set required. The lower Southeast Queensland border region was assessed as an 'acceptable' distance from the Lismore Local Government area, to ensure necessary resources are able to be secured under this panel, to suit the varying needs of Council.

Evaluation Results and Preferred Tenderers

After assessing all submissions based on the agreed criteria and weightings, the evaluation team concluded with the recommendation of five (5) unranked approved suppliers to be included on the Vacuum Excavation and Pump Out Services Panel.

The list of preferred tenderers has been recommended based on demonstrated experience, capability availability and capacity, as well as inclusion on previous Council Panel Contracts, with demonstrated benefit to our local and regional economies.

Summerland Environmental, Mega Waste Industries Pty Ltd and Field Directional Drill are all local providers who have the proven availability, capacity and capability to provide the necessary services required for Council's planned or routine work programs and emergency events.

Dynamic Hydro Excavations Pty Ltd and Total Drain Cleaning Services Pty Ltd, although based in Southeast Queensland are a desired addition to the panel, due to the size of their fleet and the capacity required during a major emergency situation such as large scale power outages or pump failures. In the event that local companies were unavailable, these companies would be able to be mobilised relatively quickly to assist Council in emergency situations.

This list of preferred tenderers will provide the flexibility needed to satisfy Council's requirements for vacuum excavation routine maintenance activities as well as pump out services for planned outages and emergency breakdowns.

Probity Check

A credit check was conducted on the 17th June 2024, through Creditor Watch on all preferred tenderers to be included on the Vacuum Excavation and Pump Out Services Panel. All suppliers have a risk score rating ranging between low to neutral risk level with no adverse information found relating to court action, registered defaults, or mercantile enquiries.

Tendering methodology was pursuant to Section 169(1)(b) of the Local Government (General) Regulation 2021. The Request for Tender was advertised on VendorPanel for a period of greater than 21 days.

Comments

Finance

The recommendation is supported as printed.

Conclusion

An assessment of submissions received under Tender T2024/11 Vacuum Excavation and Pump Out Services has been undertaken.

The assessment process has identified a list of suitable suppliers to be included on an un-ranked panel of providers. Executive Summary

The purpose of this tender is to select a suitably qualified company with the capability, experience and availability to install subsurface drainage systems to flood affected sporting fields in the Lismore flood basin. This project is funded under the Community Assets Program, part of the 2022 Community Local Infrastructure Recovery Package offered by Regional NSW.

It was identified that the funding amount of \$694,530.00 is insufficient to deliver the full scope of drainage work as per the original scope of tendering for all six sports fields (being Nesbitt, Blair, Mortimer, Nielson, Davidson and Roder Ovals).

To deliver the planned works within the available funding amount, and in consultation with internal and external stakeholders, it was decided to reduce the scope from six to four sports fields. Davidson and Roder Ovals were removed from the original scope basing on hierarchy of sporting needs and user patronage.

This report details the evaluation of the 11 tenders received and provides a recommendation to Council to accept the tender from Twin View Turf Pty Ltd at a cost of \$559,111.00 including GST.

Council has applied for additional grant funding of \$204,314.60 to complete the remaining scope of works and proposes, should the additional grant funds be received, that a fixed price variation for the remaining two sites be executed.

Background

Following the flooding event of 2022, significant drainage issues have been observed at a number of Council's sporting fields in the Lismore basin. This issue reduces the capacity of fields to cater for sporting events and diminishes the amenity of fields in our landscape.

To improve field drainage, the fields in the Lismore basin were investigated by a professional sports turf consultant and a scope of works and budget developed. An application was subsequently made for funding from the Community Assets Program, part of the NSW Flood Recovery Program offered by Regional NSW. A total grant of \$694,530.00 was approved under this program.



All Price submissions were checked for accuracy and that all the necessary inclusions and optional inclusions for additional work had been priced.

It was found that Precision Projects did not provide a price as requested at Option A for Additional Work and was therefore deemed a non-compliant tender.

It was identified that the project funding amount of \$694,530.00 was insufficient to deliver the full scope of drainage work as per the original scope of tendering for all six sports fields (being Nesbitt, Blair, Mortimer, Nielson, Davidson and Roder Ovals).

To deliver the planned works within the available project funding amount, and in consultation with internal and external stakeholders, the panel agreed to reduce the project scope from six to four sports fields. Davidson Oval and Roder Oval were removed from the original scope based on hierarchy of sporting needs and user patronage.

Almost half the pool of 10 conforming tenderers were assessed as capable and experienced in delivering the tendered works. Twin View Turf scored highly on capability, experience and availability. 
